04. The Settler has constituted the Trust on the 28th day of September 2015, as a PUBLIC EDUCATIONAL TRUST. This Trust is noted for the benefit of the poor and the and under privileged section of the society, without any distinction of caste, creed, colour, religion or sex.
- a) To inculcate the habit of study and highlight the importance of Education in the social reformation of the society.
 - b) To work for the eradication of illiteracy.
 - c) To provide free education to the poor, subsidized education at higher education level as the case may be to the deserving poor and the economically weakest sections of the society, who cannot take up higher education or who have been deprived of education.
 - d) To provide proper guidance and advice. to the people regarding the importance of education in their lives.
 - e) To arrange for the Sri Jai Maruthi Education Trust on basic education, mass education and adult education programmes by arranging Lecturers, Audio Visual shows, display of posters, publication-of books, pamphlets, through Radio Programmes, TV programmes with the help of specialists.
 - f) To conduct surveys, studies regarding the prevalence of illiteracy in rural urban and cities etc., and to eradicate illiteracy.



To purchase all types of equipments, Articles, Machines other products necessary for the running of educational institution and Motor Vehicles for the benefit of students and the employees of the Trust.

- j) To invest, to dispose off, to transfer, to gift, to present, otherwise deal with the subject matter of the Trust in such manner as trustees deem fit so as to enable the Trust to carry out its objectives effectively.
- k) To accept donations, grants, presents, awards, subsidies and offerings from the Central or State Government, General Public or any statutory body or companies or any other institutions either in cash or in kind and deal with the same for the purpose of the Trust.
- l) To recoup themselves for the expenses incurred in the upkeep and maintenance of this Trust or of any institutions if any, established under this Trust.

Provide that the maximum number of Trustees shall be 9 and the minimum shall be 2, including the permanent Trustees

11. The Board of trustees shall be in charge of the management and administration of the Trust. In the event of the Trustee's Place becoming vacant due to death incapacity or resignation or for any other reason, the vacancy will be filled up by appointing suitable persons by the other Trustees as decided by-a majority vote.
12. The Board of Trustees shall manage the subject matter of the trust economically and by circumspection as they may jointly at a meeting or by circulation resolve upon them.
13. The Board of Trustees shall meet as often as necessary to transact the business of the Trust. However there shall be at least one meeting of the Trust in 3 months in the first year. The secretary of the Trust, or on request of any of the Trustees the secretary shall convene a meeting of all the Trustees.
14. The Board of Trustees are empowered to open Bank Accounts in the name of the Trust and operate the same.
15. The Board of Trustees are empowered to borrow money on behalf of the Trust with or without security for the purpose of the Trust. For the purposes of borrowing the money, the secretary to the Trust, empowered by the Resolution of the Trust, shall have power to sign the promissory notes, bills, of exchange, Hundis, or any other documents that may be necessary for and on behalf of the Trust.
16. The Secretary shall maintain proper accounts and the same shall be got annually audited by Chartered Accountant or by any other person qualified in the audit of the accounts of a joint Stock Company and shall be approved by the Trust.

17. The Board of Trustees shall have power to acquire, possess, own, hold and enjoy all the properties movable and immovable on behalf of the Trust and also to sell, dispose of, alienate, encumber, lease all such properties for and in name of the Trust and to derive all such income there from and invest such income there from as they consider best in the interest of the Trust and the name of the Trust.
18. The Board of Trustees shall have power to raise funds by way of donations, contribution, fees, grants from patrons, donors, Trustees or the Government or Government agencies and the public at large, in the interest and furtherance of the objectives of the, Trust, not inconsistent with the provisions of the income Tax Act and Rules Governing the Charitable Societies and Associations.
19. The Board of Trustees shall have power to frame such subsidiary rules for the conduct of their business and shall have power further to alter and to amend the same from time to time as may be necessary in the conduct of their business not inconsistent with the provisions of the Income Tax Act governing the Public Charitable Trust.
20. The Board of Trustees shall have power to expand the objectives of this Trust.
21. The Board of Trustees shall be at liberty to do such acts as are necessary to realize the objectives and purposes of the Trust and all actions taken by the Trustees in this regard shall be got approved by the Trust.

The Board of Trustees Shall have power to appoint such Staff and employees on such, remuneration as they may deem fit in the administration of the Trust.

22. The Board of Trustees may wind-up the Trust and transfer all the assets of the Trust to any other charitable Trust or Association or institution-that have similar objectives as the Trust. In the event of. such winding up or merger no asset or benefit of the Trust shall endure or accrue to the advantage of the Trustees.
23. Any question arising in the administration of the Trust shall be decided by mutual -consultation by the Trustees and in the event of any disagreement the decision of the majority of Trustees present shall prevail.
24. After defraying all expenses incurred in the realization of the income of the subject matter of the Trust, the balance of the income shall, be deposited in any schedule Bank.
25. The Board of Trustees may out of the Corpus of the Subject Matter of the Trust:, spend -such money or appropriate such money or part there of for laying out, erecting, furnishing any building or for incurring any Capital Expenditure as may be resolved upon by the Trustees.
26. The Trustees, shall among themselves elect a Secretary to the Trust who will be in charge of the daily working and promoting the cause of Trust and all the duties and responsibilities assigned there under.
27. The Secretary shall carry on the objectives of the Trust with such funds as may be made available to him by the Trustees. The Secretary of the Trust shall render accounts to the Trustees of all funds receive, realized, grants, payments donations, awards presents monies and other properties received by him from whatever source and also all the expenditure incurred by him he shall arrange for a Audit of the same and maintain true and correct accounts. He shall also maintain minutes and proceedings of all meetings.

31. The Secretary of the Trust is entitled for a monthly honorarium and the other Trustees are entitled for a sitting fee or the honorarium for all meetings they attend to and other incidental expenses which shall be decided by the Trustees.
32. The Board of Trustees may constitute such committees or subcommittees from among the Trustees including the SETTLER or the DONORS to the Trust for different purposes for carrying out the objectives of the Trust more effectively.
33. All the Trustees who have been invested with the ownership and possession of the subject matter of the Trust, and all the property of the Trust is transferred to the Trustees.
